

## 2. AIMS AND OBJECTIVES

1. To impart education to children to all communities and nationalities and all castes and creeds desiring to receive education of the type offered by this Trust through its educational institutions.
2. To provide, manage and administer scholarships of the type offered by this Trust to needy children for educational purposes.
3. To initiate, administer, manage, encourage and support educational and medical institutions.
4. To establish, construct, equip, maintain, administer and conduct branches, offices, halls, hostels, boarding houses, libraries, reading and lecture rooms, congresses, conferences, study classes, canteens, gymnasiums, cultural and educational institutions' activities, functions, works, facilities and amenities which may be necessary or convenient for the purpose or objects of the Trust.
5. In the case of any institution whose objects are Educational, Medical or charitable can be transferred to the Trust's administration, and to maintain any such institution.
6. To encourage, co-operate with institutions, associations and persons who cherish similar principles and goodwill and the development of high ethical standards in personal and family life and relationships, and to provide, organise maintain, administer and conduct institutions, functions and facilities for such purposes.



7. To establish, provide, organise, maintain, administer, supervise, control and conduct institutions for the study and appreciation of indigenous and foreign languages and literature, arts and sciences, book shops on a no profit or loss basis, printing and publishing establishments, studios, research centres, laboratories, undertaking scheme, work or activity whatsoever.
8. To make available to the public the medical facilities provided by the Trust in the area of curative and preventive through hospitals and dispensaries.
9. To take over, establish, endow, maintain, administer, carry on, conduct, dispose off and otherwise deal with hospitals, dispensaries, infirmaries, maternity homes, nurseries, nursing homes and wards, nursing schools, para medical training and institutions, psychiatric clinics, rehabilitation centres, ambulance work, medical colleges and training classes, research institutes, convalescent homes, clinics for outdoor and indoor relief, laboratories, creches, and other medical institutions, works amenities and activities.
10. To educate, train, and instruct adults and children, irrespective of race, religion, community, caste, language or social status by taking over, establishing, endowing, conducting, maintaining, administering and carrying on schools, colleges and institutions for their educational instruction and training in all subjects, liberal and technical and to develop, add, equip, improve, alter, close down, dispose if and otherwise deal with such schools, colleges and institutions.
11. To help weaker section of the society irrespective of caste, creed and religion, for their socio-economic upliftment by all legitimate and constitutional means.
12. Generally to do such acts, deeds and other things which are incidental and conducive to the attainment of all or any other of the above objects

### 3. TRUST FUND AND PROPERTY

The sum of Rs. 1000/- (Rupees One Thousand Only) hereinafter called the Trust Fund is collected as the nucleus of the TRUST FUND to carry out the aims and objects of the TRUST. Funds will be raised by accepting donations, freewill offering, Endowments, gifts or contributions in India and abroad in cash or kind, properties movable foundations, bequests, from any person or persons, establishments, organisations. Institutions and Governments etc., for the furtherance of the aims and objects of the TRUST and upon such terms and conditions as the Trust may in its absolute discretion, decide.

AND WHEREAS for the better and more effectual HOLDING, USING and ADMINISTERING of the TRUST PROPERTY and such other funds and/or property as may be entrusted to the TRUSTEES or any successors of them in pursuance of these presents it is RESOLVED TO MAKE A DECLARATION OF TRUST concerning the TRUST FUND appoint TRUSTEES and delegate POWERS for the HOLDING USING AND ADMINISTERING of the TRUST PROPERTY and such other assets and may be entrusted to the TRUSTEES or their successors in pursuance of these presents.

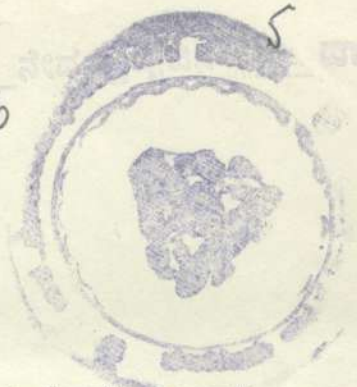
NOW THIS DEED WITNESSETH that in consideration of these presents the TRUSTEES of the TRUST PROPERTY to HAVE, HOLD AND ADMINISTER the same for the TRUST PURPOSES hereinbefore recited in accordance with the POWERS hereinafter contained.

### 4. NAME OF THE TRUST AND ITS ADDRESS

The name and style of the TRUST shall be "NEW LIFE REACHING HAND" situated for the time being at 60/2, 60 Feet Road, Kammanahalli Extension, Bangalore-560 084.

5. POWERS

In pursuance of the foregoing objects (but not further or otherwise) the TRUSTEES are hereby EMPOWERED.

- i. To purchase, take on lease or in exchange, hire or otherwise acquire any property, real or personal, immovable or movable and any rights or privileges necessary for the promotion of the objects of the TRUST and to construct, alter, improve and maintain any buildings or erections or other property necessary for the work of the TRUST.
- ii. To sell, let, mortgage, dispose of or turn to account all or any of the properties or assets of the TRUST in future.
- iii. To borrow or raise or secure payment of money in such manner as the TRUST may think fit and to secure the same or the repayment or performance of any debt, liability or contract, guarantee other engagement incurred or to be entered into by the TRUST in any way.
- iv. To permit any agents or any other persons authorised by the TRUST to use and occupy any building, erections or other property of the Trust on such terms and conditions as the Trust may deem fit.
- v. To enter into any arrangement with any Government or authority Central, State, Municipal or otherwise in pursuance of the objects of the TRUST and to obtain from any such Government or authority all rights concessions and privileges which may seem conducive to the TRUST'S objects or any of them.
- vi. To undertake and execute Charitable Trusts.
- vii. To receive and take any gift or money or other property for any of the objects of the TRUST and whether subject to any special Trust or not but so that the TRUST may nevertheless decline to accept any gift or take over any property having annexed to it any condition or obligation not apporved by the TRUST.

- viii. The funds of the TRUST shall be invested in the modes specified under the provisions of Sec. 13(1) (d) read with section 11 (5) of the Income-tax Act, 1961.
- ix. To employ all such officers and servants as may be required for the purpose of the TRUST.
- x. To act as agents for any person, body, society or undertaking in any matter and in any lawful manner for the furtherance of the above objects of the TRUST.
- xi. To open branches of the TRUST at any place in India.
- xii. The Board of Trustees shall lay down General policy for the furtherance of the aims and objects of the Trust.
- xiii. The Board of Trustees shall appoint standing committees or sub-committees for any General or special purpose for the efficient running of the Trust.
- xiv. To do all such other things as are necessary for the attainment of the above objects or any of them.
- xv. The funds and the income of the Trust shall be solely utilised towards the achievement of the objects and no portion of it shall be utilised for payment to Trustees by way of profit, interest, dividends etc.
- xvi. The Trust formed is irrevocable.
- xvii. The benefit of the Trust shall be open to all irrespective of caste, creed or religion.

6. MANAGEMENT

The management of the Trust shall vest with the Board of Trustees which shall comprise of not more than FIVE Trustees. The TWD founder Trustees shall be the First Board of Trustees who shall be empowered to co-opt Three more Trustees to the Board.

7. THE TRUST

THE TRUST PROPERTY is to be used for the furtherance of the activities as aforementioned and for such other similar activities as majority of the TRUSTEES or their successors shall at any time, determine.

8. THE TRUSTEES

The founder Trustees shall be the Trustees of the Trust for life unless and until they voluntarily resign. All other Trustees shall hold office for a term of Two years and eligible for re-election.

The number of TRUSTEES of the said TRUST shall not at any time be less than Two and when they are only Two Trustees additional TRUSTEES shall forthwith be appointed PROVIDED nevertheless that the number of TRUSTEES shall not at any time exceed FIVE. Trustees of the Trust shall consist of founder Trustees as well as the Trustees appointed in pursuance of this Deed. All Trustees appointed under this clause shall act in the execution of the Trusts and powers of this Deed together with the Trustees named in this Deed.

9. ANY of the TRUSTEES may retire from the TRUST hereof by notifying his/her fellow TRUSTEES in writing of his/her intention so to do, and from the date of receipt of such notification, the retiring TRUSTEE shall be discharged from the TRUST hereof.

10. If any one of the Trustees dies or becomes bankrupt, insolvent or mentally incapacitated or in the judgement or majority of the other TRUSTEES signified by them in writing under their respective hands conducts himself in a manner unbecoming of a TRUSTEE such TRUSTEE shall cease to be a TRUSTEE OF THIS TRUST.

11. No person shall be appointed as TRUSTEE who under the preceeding clause would be lawfully unable to continue to be a TRUSTEE.

12. CHAIRMAN

Mr. V.M. Samuel shall be the Chairman of the Trust for life unless and until he voluntarily resigns.

**13. EXECUTIVE DIRECTOR**

He shall be elected by the General body of the Trustees and shall arrange for the proceedings of all the meetings of the TRUST. He shall arrange for the carrying out of the instructions given at such meetings and attend to all statutory requirements imposed on the TRUST. He shall convene the meetings of the TRUST in consultation with the CHAIRMAN.

The EXECUTIVE DIRECTOR will have such powers as may be provided in the regulations to be framed from the day to day management of the Trust. The EXECUTIVE DIRECTOR shall at all times during the period of office as such devote full attention to the various activities of the Trust and employ faithfully and diligently and carry out all necessary steps to ensure the advantage and efficient management of the Trust. The EXECUTIVE DIRECTOR shall for services rendered be entitled to draw a monthly salary and other perquisites as may be decided upon by the Trustees from time to time.

**14. TREASURER**

He shall be elected by the General Body of the Trustees and shall be responsible for the maintenance of accounts and finance of the TRUST and shall present the audited statement of accounts to the General Body of the Trustees.

**15. BANK ACCOUNTS**

Bank accounts of the TRUST shall be opened in the name of the TRUST

**16. THE ACCOUNTS**

There shall be maintained accounts of the TRUST regularly. The accounts shall be audited by a Chartered Accountant every year. Accounts shall be closed every year by 31st of March.

**17. MEETINGS OF THE TRUSTEES**

MEETINGS OF THE trustees shall be called by the EXECUTIVE DIRECTOR when the affairs of the TRUST so demand but atleast once in every year, such annual meetings being known as the ANNUAL GENERAL MEETING of the TRUST or whensoever a meeting is requisitioned by THREE of the TRUSTEES for the time being. TWENTY ONE days notice shall be given to all meetings and a detailed agenda of the business to be transacted at all meetings shall accompany these respective notices calling such meetings. At every annual General Meeting of the TRUST, the EXECUTIVE DIRECTOR shall lay before the meeting the report of the activities of the TRUST since the previous Annual General Meeting.

18. A circular resolution issued by the EXECUTIVE DIRECTOR in consultation with the CHAIRMAN on any subject and signed by the majority of the TRUSTEES, shall in all respects, be valid and binding as a resolution passed at a meeting of the Trustees duly convened and constituted and such resolution shall not be deemed invalid by reason of want of notice or any other cause whatsoever.

19. TWO TRUSTEES personally present at a meetings shall form quorum.

20. DECISIONS OF THE TRUSTEES

Except where otherwise provided any question arising as to the property or any transaction of the TRUST shall be conclusively settled as between all parties concerned by decision of majority of the number of TRUSTEES for the time being.

21. THE PROPERTY OF THE TRUST

THE TRUST FUND now vested in the TRUSTEES and any other funds, property hereafter entrusted to the TRUSTEES for the time being or any one or more of them by gift or other means shall from the date of such funds becoming so vested be HELD and ADMINISTERED by the TRUSTEES for the time being in accordance with the terms of this deed.

22. INDEMNITY

EVERY TRUSTEE shall be indemnified out of the TRUST FUND against all losses and expenses incurred in the discharge of his duties except such as shall happen through his own negligence wilful act or default and each TRUSTEE shall be chargeable with only such money or property as he or they shall actually receive for or in the discharge affairs of the TRUST and each shall be answerable only for his own acts, neglects or defaults and not for those for any other person.

23. VARIATION OF THE TERMS OF TRUST

ALTERATIONS to the clauses of the Deed shall only be made at a meeting of the TRUSTEES after giving notice of TWO calender months which notice shall be accompanied by details of the proposed alterations and shall be subject to confirmation at a Second meeting of the Trustees held not earlier than one Calender month after the First Meeting. Clauses may be altered by the votes of Two-thirds of the number of the TRUSTEES with the prior permission of Commissioner of Income-tax. All alterations shall be confirmed by a DEED OF VARIATION OF TRUST. No amendments to the Trust deed shall be made which may prove to be repugnant to the provisions of Sec. 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 amended from time to time.
